- 1.11 Cost incurred by the bidder in preparing and submission of any bid proposal will be borne by the bidder and the South African Weather Service will not be liable to reimburse such costs incurred by the bidder of his/her representative/s.
- 1.12 The South African Weather Service shall on receipt of any proposal relating to this bid become the owner thereof and shall not be obliged to return any proposal.
- 1.13 The bidders shall indemnify the South African Weather Service against all third-party claims of infringement of patent, trademark, or industrial design rights arising from the use of the goods or any part thereof by the South African Weather Service.
- 1.14 The South African Weather Service reserves the right to request a bidders latest audited financial statements prior to the award of the bid in order to ascertain financial stability of the bidder. Failure by a bidder to provide such information upon request may result in the rejection of the bid submitted by the bidder.
- 1.15 Subcontracting: Tenderers or contractors must submit proof of subcontracting between the main tenderer and the subcontractor. Proof of subcontracting arrangement may include a subcontracting agreement between the main tenderer and the subcontractor.
- 1.16 The SAWS reserves the right to request final presentation only to the short listed bidders to the evaluation committee. The shortlisted service providers will be subjected to present their service offering in line with the bid requirements/scope of work. The SAWS might also conduct site visit to ensure the firm existence and validate the firm's proposed capacity/employees and administration office.
- 1.17 The service provider must have duly approved operational premises with the necessary infrastructure to provide services and relevant accreditation by the relevant body. Before the awarding of the tender a due diligence site visit will be carried out at the premises of the service provider.
- 1.18 Supplier Performance Management is viewed by the SAWS as critical component in ensuring value for money acquisition and good supplier relations between the SAWS and all its suppliers. The successful bidders shall upon receipt of written notification of an award, be required to conclude a SLA with the SAWS, which will form an integral part of the supply agreement. The SLA will serve as a tool to measure, monitor and assess the supplier's performance level and ensure effective delivery of service, quality and value-add to SAWS's business. Successful bidders are required to comply with the above condition, and also provide a scorecard on how their product / service offering is being measured to achieve the objectives of this condition.
- 1.19 The SAWS respects your privacy and acknowledge that your submission/s will contain personal details, which may belong to you, others and / or to your company (Personal Information). - 1.20 Unless stated otherwise in this Bid or as mutually agreed upon by both parties prior to award of the



Bid, all payments due to creditors for goods delivered / services rendered will be settled within thirty (30) days from receipt of an invoice.

2. TAX COMPLIANCE REQUIREMENTS

- 2.1 Bidders must ensure compliance with their tax obligations.
- 2.2 Bidders are required to submit their unique Personal Identification Number (PIN) issued by the South African Revenue Service (SARS) to enable the South African Weather Service to verify the taxpayer's (Bidder's) profile and tax status.
- 2.3 Application for a Tax Compliance Status (TCS) Pin may be made via e-filing through the SARS website www.sars.gov.za
- 2.4 Bidders may also submit a printed Tax Compliance Status (TCS) certificate together with the bid.
- 2.5 In bids where consortia / joint ventures / sub-contractors are involved **each** party must submit a separate TCS certificate / Pin / CSD number.
- 2.6 Where no TCS Pin is available but the bidder is registered on the Central Supplier Database (CSD), a CSD number must be provided.
- 2.7 No bids will be considered from persons in the service of the state, companies with directors who are persons in the service of the state, or close corporations with members persons in the service of the state.
- 2.8 Foreign suppliers with neither South African tax obligations nor history of doing business in South Africa must complete the questionnaire on page 2 and 3 of Annexure A. In instances where a recommendation for award of a bid will be made to a foreign bidder, the South African Weather Service will submit the bidders completed Annexure A bid document to the South African Revenue Service. The South African Revenue Service will then issue a confirmation of tax obligations letter to the South African Weather Service confirming whether or not the foreign entity has tax obligations in South Africa.



General Conditions of Contract

1. Definitions	1.	The following terms shall be interpreted as indicated:
	1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
	1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
	1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
	1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
	1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
	1.6	"Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
	1.7	"Day" means calendar day.
	1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
	1.9	"Delivery ex stock" means immediate delivery directly from stock actually on hand.
		"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such

		obligations of the supplier covered under the contract.
		Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.
2. Application	2.1	These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
	2.2	Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
	2.3	Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.
3. General	3.1	Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
	3.2	With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za
4. Standards	4.1	The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
5. Use of contract documents and information; inspection.	5.1	The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
	5.2	The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
	5.3	Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
	r	the supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
6. Patent rights	6.1	The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance security	7.1	Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
	7.2	The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
	7.3	The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:



1 DESCRIPTION

This bid calls for the appointment of service provider/s to provide security services to remote radar sites of the South African Weather Service for a period of 36 months as from 1 April 2024 to 31 March 2027.

2 INTRODUCTION

The South African Weather Service (SAWS) is a public entity of the Department of Forestry, Fisheries and the Environment (DFFE) and derives its mandate from the South African Weather Service Act (No 8 of 2001 as amended). The public entity is listed as a Schedule 3A Public Entity in terms of the Public Finance Management Act (PFMA).

SAWS is tasked with providing timely and accurate scientific data in the field of meteorology to the broader South African society: a combination of both public good and commercial services. The organisation plays a vital role in South African public life, not just as a provider of key services, but also in empowering citizens to adapt the effects of the ever-changing weather.

3 BACKGROUND

SAWS operates a number of weather radars of which some are located in remote areas. Measures such as perimeter fencing, electric fencing as well as CCTV cameras and alarm systems were installed to deter and prevent unauthorised access to these sites. The service provider is required to provide security services such as Monitoring, Armed Response and interfacing on the existing Alarm Systems.

4 REQUIREMENT / SCOPE OF WORK

4.1 Technical / Functional requirements

SAWS would like to appoint a service provider/s to render the following services described under section 4.2 at the radar sites listed in the table below for a period of thirty-six (36) months as from 1 April 2024 until 31 March 2027. Bidders are allowed to bid for rendering the services at all the sites or at selected sites only.

- 4.2 Services to be rendered by the appointed bidder during the full contract duration period of 36 months:
 - 4.2.1 Remote monitoring of <u>alarm system</u> at each radar site 24/7/365 from a dedicated control room by trained security personnel. (Linking the alarm system to control room of security service provider will be the responsibility of the bidder and the cost thereof must be included in the bid price.)
 - 4.2.2 Remote monitoring of <u>CCTV camera footage</u> at each radar site from a dedicated control room by trained security personnel. (Linking the CCTV camera system to control room of security service provider will be the responsibility of the bidder and the cost thereof must be included in the bid price.)
 - 4.2.3 Report any suspicious activity or triggered alarms immediately to the South African Weather Service.
 - 4.2.4 The service provider must provide SAWS (2 staff SAWS members) with access via a software application to view live CCTV camera footage. All costs for utilising the software application must be included in the bid price.



4.2.5 React and dispatch an armed response service to arrive at the radar site within the specified period in the event of a triggered alarm or in instances where CCTV footage shows suspicious activities and unauthorised entry at the radar site.

- 4.2.6 CCTV footage viewed and received by the control room must be recorded and safeguarded by the service provider for a period of at least 30 days. Such recordings must be made available to SAWS upon request.
- 4.2.7 Physically visit each radar site at least once a week and perform a physical inspection (walk-around) of the premises to verify that there were no attempts to or unauthorised access gained to the site.
- 4.2.8 Cooperate with the South African Police Service (SAPS) and provide detailed statements / evidence / reports to SAPS in instances where individuals unlawfully gained access to the property or attempted to access the property without authorization.
- 4.2.9 Ensure that the alarm system, CCTV and electric fence are operational at all times. Any faults to the systems must be reported immediately to SAWS and a quotation must be provided to SAWS within 48 hours for repair of the system. No repairs must be carried out without prior written approval and acceptance of the quotation by SAWS.
- 4.2.10 Provide monthly report to SAWS with the following details of events:
 - a) Details of when the alarm was triggered and when CCTV footage showed unauthorised movement / entry at the site. (Refer to 4.2.1 and 4.2.2)
 - b) Details of when the site was visited by the security company (Date, time and name of security officer who visited the site as well as condition of site.) (Refer to 4.2.5 and 4.2.7)
 - c) Details of any repairs done to the alarm, CCTV and/or electric fence system during the specific month. (Refer to 4.2.9)



- 4.3 Bidder to advise SAWS during the contract duration if there are any deterrent mechanisms that can be installed at the radar sites to deter and delay unauthorised entry to the premises.

5.2 Mandatory Technical / Functional requirements.

The following information must be submitted with the response to this bid invitation. Bidders who fail to provide the information or evidence as requested will be regarded as non-responsive to this bid invitation.

5.2.1 Proof of registration of the bidder (bidding entity) with the Private Security Industry Regulating Authority (PSIRA).

It is a mandatory requirement that the bidder must be registered with the Private Security Industry Regulatory Authority (PSIRA). A certified copy of the PSIRA registration of the bidding entity must be submitted with the bidder's response to this bid.

5.2.2 Physical address of control room/s.

It is a mandatory requirement that the bidder must provide the physical address/es and contact details of the control room/s for each of the sites the bidder is bidding for. Bidders must indicate which control room will be monitoring which of the radar sites. The information must be submitted with the bidder's response to this bid.

5.2.3 Armed response service

Bidders must indicate if the bidder will be using a service provider other than the bidder to provide an armed response service as required under section 4.2 above.

5.2.4 In the event where a service provider other than the bidder (3rd party) will be providing the armed response service the bidder must submit written confirmation from the 3rd party confirming that the armed response service will be provided as mutually agreed upon between the bidder and the 3rd party. Proof of registration of the 3rd party with PSIRA must also be provided with the bid response of the bidder.

5.3 **Technical / Functional evaluation**

Technical / Functional evaluation of the bid will be done in terms of the criteria as stated in the table below. Bidders should take note of the Criterion, Weighting & Scoring when responding to this bid.

5.4 **PRICE AND SPECIFIC GOALS EVALUATION**

Bidders who comply with the requirements of this bid will be evaluated according to the preference point scoring system as determined in the Preferential Procurement Regulations, 2022 pertaining to the Preferential Procurement Policy Framework Act, Act No 5 of 2000.

The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

The value of this bid is estimated NOT to exceed R50 000 000 (all applicable taxes included) and therefore the 80/20 preference point system shall be applicable.



Points for this bid shall be awarded for:
